TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "Termination and Release") dated as of April 1, 2021, made by CANADIAN IMPERIAL BANK OF COMMERCE, in its capacity as administrative agent (in such capacity, the "Administrative Agent") for and on behalf of the beneficiaries, is in favor of BIONERA RESOURCES INC. (the "Obligor"). All capitalized terms used by not otherwise defined herein have the meanings given to them in the Intellectual Property Security Agreement (as defined below).

WHEREAS, the Obligor executed an Intellectual Property Security Agreement dated August 9, 2018 (the "IP Security Agreement"), in favor of the Administrative Agent, granting the Administrative Agent security interests in and liens on certain trademarks described therein (the "Trademark Collateral");

WHEREAS, the IP Security Agreement was recorded with the United States Patent and Trademark Office ("USPTO") on January 3, 2019 at Reel 6515, Frame 0681; and

WHEREAS, the Administrative Agent now desires to terminate the IP Security Agreement and terminate, release and discharge its security interest in all Trademark Collateral including the United States registered trademarks set forth in Schedule A hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby:


1. terminates the IP Security Agreement and absolutely, unconditionally and irrevocably terminates, releases, cancels and discharges all pledges, grants, liens and security interests in the Obligor's right, title and interest in, to and under the Trademark Collateral under the IP Security Agreement, including the Trademark Collateral identified in Schedule A hereto;
2. authorizes and requests that this Termination and Release be recorded at the USPTO; and
3. understands and agrees that this Termination and Release may be recorded by or for the Obligor or its successors or assigns with the USPTO.


THIS TERMINATION AND RELEASE AND ANY CLAIM, CONTROVERSY, DISPUTE OR CAUSE OF ACTION (WHETHER IN CONTRACT OR TORT OR OTHERWISE) BASED UPON, ARISING OUT OF OR RELATING TO THIS TERMINATION AND RELEASE AND THE TRANSACTIONS CONTEMPLATED HEREBY SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAW OF THE PROVINCE OF ALBERTA AND THE LAWS OF CANADA APPLICABLE THEREIN, EXCLUDING CONFLICT OF LAW RULES OF THAT PROVINCE.
