This Assignment is made by Assignor to Assignee free from any notice or claim asserted or threatened by any third party due to the infringement of any trade name, trademark, service mark, copyright, or license of any person or organization. Assignee hereby accepts this Assignment.

**Section 2. Effect of Assignment**

This Assignment is intended to be and is an absolute assignment of all right, title, and interest of Assignor in and to the IP Assets, agreements, contracts, and license agreements, including the Zacuto Agreement. This Assignment is not executed as security in any respect. From and after the date of this Agreement, Assignee shall be the sole and lawful owner of the interests of Assignor in and to the IP Assets and shall have all rights of Assignor in relation to the IP Assets.

**Section 3. Warranty of Title and Right to Convey**

Assignor believes that it is the sole and absolute owners of the IP Assets as set forth above with good and valid right to transfer and convey the IP Assets and the above-identified U.S. Federal Registration and Serial Numbers to Assignee.

**Section 4. Future Assurances**

Assignor shall, upon the request of Assignee, execute and deliver such additional documents as may be necessary or convenient for the purpose of evidencing or perfecting any rights and interests arising under this Agreement.

**Section 5. Continuous Use**

Assignor warrants and swears that all of the above IP Assets have been and still are in continuous use since the date of first use and in continuous use in commerce since the date of first use in commerce indicated in any State and Federal Registrations. Including, Assignor warrants and swears that the mark "Players", registration no. 1,333,170, serial no. 73492733, although the trademark application appears abandoned, has been and still is in continuous use in commerce since June 29, 1984 to the present in connection with guitar strings, drums, drum accessories including drumsticks, picks for stringed instruments, band and orchestra instruments, band and orchestra instrument accessories, and other musical instrument accessories.
