RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this “Release”) is made as of April 6, 2021 (the “Effective Date”) by Cortland Capital Market Services LLC, in its capacity as collateral agent for the Secured Parties (in such capacity, together with its successors and permitted assigns, the “Collateral Agent”), in favor of SimplyWell, Inc., a Delaware corporation, Viverae Vital, Inc., a Delaware corporation, Redbrick Health Corporation, a Delaware corporation, Virgin Pulse, Inc., a Delaware corporation, ShapeUp, Inc., a Delaware corporation and Preventure, LLC, a Delaware limited liability company (collectively, the “Pledgors”).

WITNESSETH:

WHEREAS, pursuant to the terms and conditions of (i) that certain Trademark Security Agreement between the Pledgors party thereto and the Collateral Agent, dated as of May 22, 2018 and (ii) that certain Trademark Security Agreement between the Pledgors party thereto and Collateral Agent, dated as of November 27, 2018 (collectively, the “Trademark Security Agreements”), the Pledgors granted to the Collateral Agent to secure the Secured Obligations (as defined in the Security Agreement, dated as of May 22, 2018, among the Pledgors party thereto and the Collateral Agent (as amended, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”) a security interest in and to the Trademark Collateral (as defined in the Trademark Security Agreement);

WHEREAS, pursuant to the terms and conditions of that certain Patent Security Agreement between the Pledgor party thereto and the Collateral Agent, dated as of May 22, 2018 (the “Patent Security Agreement”), the Pledgor granted to the Collateral Agent to secure the Obligations a security interest in and to the Patent Collateral (as defined in the Patent Security Agreement);

WHEREAS, the Trademark Security Agreements were recorded with the United States Patent and Trademark Office on (i) May 23, 2018, at Reel/Frame number 6335/0231 and (ii) December 4, 2018 at Reel/Frame number 6493/0979, in each case against the Trademarks on Schedule 1 to the applicable Trademark Security Agreement, which lists of Trademarks are attached as Annex A hereto;

WHEREAS, the Patent Security Agreement was recorded with the United States Patent and Trademark Office on May 24, 2018 at Reel/Frame number 046227/0461, against the Patents listed on Schedule 1 to the applicable Patent Security Agreement, which are attached as Annex B hereto;

WHEREAS, the Collateral Agent now desires to terminate each Trademark Security Agreement and the Patent Security Agreement, and release its security interest in and to the Trademark Collateral and the Patent Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Security Agreement, the Trademark Security Agreements or the Patent Security Agreement, as applicable.
2. Release of Security Interest in Collateral.

The Collateral Agent, on behalf of itself and the Secured Parties, hereby terminates, releases, and discharges any and all liens, security interests, right, title, and interest the Collateral Agent or any Secured

Party may have in, to, or under the Trademark Collateral and the Patent Collateral, and reassigns to the applicable Pledgor any and all right, title, and interest the Collateral Agent and any Secured Party may have in, to or under the Trademark Collateral and the Patent Collateral, together with the goodwill of the business symbolized thereby.

The Collateral Agent hereby acknowledges and agrees that the Pledgors have completely and timely satisfied their obligations in full, and hereby terminates each Trademark Security Agreement and the Patent Security Agreement. The Collateral Agent hereby confirms that no Pledgor shall have any further obligations of any kind under the Trademark Security Agreements or the Patent Security Agreement.

The parties hereto authorize and request the Director of Patents and Trademarks of the United States of America or her delegate to record this Release against the Trademark Collateral and the Patent Collateral. The Collateral Agent hereby represents and warrants that it has full power and authority to execute and deliver this Release.

3. Governing Law. This Release shall be governed by and construed in accordance with the laws of the State of New York.

4. Counterparts. This Release may be executed in any number of counterparts, all of which shall constitute one and the same instrument, and any party hereto may execute this Release by signing and delivering one or more counterparts.
