THE FOLLOWING HAS BEEN STATED AND AGREED UPON:

1. At the price of USD 100, the ASSIGNOR has agreed and confirmed to assign to the ASSIGNEE the USA Trademark Serial Number: 6237496 whose full data is listed in Schedule A attached hereto.
2. By the present Deed, the ASSIGNOR confirms the transfer to the ASSIGNEE, who accepts, of all its right of ownership to the above Mark, including the goodwill of the business, without any restriction nor reserve.
