IP SUPPLEMENT

This IP SUPPLEMENT, dated as of March 31, 2021 is delivered pursuant to and supplements (i) the Security Agreement, dated as of October 27, 2014 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement"), by and among the Grantors named therein and JPMorgan Chase Bank, N.A., as the Collateral Agent, and (ii) the Trademark Security Agreement dated as of July 1, 2019 (the "Agreement") executed by Grantor. Capitalized terms used herein and not otherwise defined herein shall have the meanings ascribed thereto in the Agreement.

Grantor grants to the Collateral Agent (for the benefit of the Secured Parties) a security interest in all of Grantor's right, title and interest in and to the Trademark Collateral set forth on Schedule A annexed hereto. All such Trademark Collateral shall be deemed to be part of the Trademark Collateral and shall be hereafter subject to each of the terms and conditions of the Security Agreement and the Agreement.
