Reference is made to (i) the Credit Agreement dated as of November 29, 2017 (as amended, restated, amended and restated, supplemented, extended, refinanced or otherwise modified prior to the date hereof, the "Credit Agreement"), among WW International, Inc. (f/k/a Weight Watchers International, Inc.), a Virginia corporation (the "Borrower"), the Lenders party thereto and JPMCB, as the Administrative Agent and an Issuing Bank, (ii) Guarantee and Collateral Agreement dated as of November 29, 2017 (as amended, supplemented or otherwise modified from time to time, the "Collateral Agreement"), among the Borrower, the Subsidiary Loan Parties from time to time party thereto and JPMCB, as Administrative Agent, and (iii) the Trademark Security Agreement dated as of November 8, 2018 among the Borrower, W Holdco, Inc. and the Administrative Agent (the "Trademark Security Agreement"), and together with the Collateral Agreement, the "Security Agreements").
- B. Pursuant to the Security Agreements, the Borrower and W Holdco, Inc.
