ASSIGNMENT OF TRADEMARKS

Assignor does hereby assign unto Assignee all right, title and interest in and to the said Marks in the United States, together with the goodwill of the business symbolized by the Marks, including all rights in and to all causes of action, either in law or in equity for past, present, or future infringement based on the Marks.

Assignor agrees to execute all papers and to perform such other proper acts as Assignee may deem necessary to secure for Assignee or its designee the rights herein assigned.
