## TRADEMARK AND COPYRIGHT ASSIGNMENT AGREEMENT

THIS TRADEMARK AND COPYRIGHT ASSIGNMENT AGREEMENT (“**Agreement**”), entered into and effective this 26<sup>th</sup> day of March, 2021, is by and between Schaafsma Holdings, LLC, a Delaware limited liability company with a place of business at 51327 Quadrante Drive, Macomb, MI 48042 (“**Assignee**”), and Perfect Comfort, Inc., d/b/a Schaafsma Heating and Cooling., a Michigan corporation with a place of business at 25 North Park St. Northwest, Grand Rapids, MI 49544 (“**Assignor**”). (b) Assignor also hereby sells, grants, assigns and transfers unto Assignee and its representatives, successors and assigns Assignor’s entire right, title and interest in and to any and all U.S. or foreign applications and/or trademark registrations arising out of said Marks, including all rights under any and all international conventions and treaties respecting said Marks in foreign countries. Assignor further authorizes Assignee to apply for protection of said Marks in the U.S. or in foreign countries directly in Assignee’s own name or any other, and to claim priority of the Marks.

2. Copyright Assignment. Assignor hereby sells, grants, assigns and transfers unto Assignee and its representatives, successors and assigns forever, Assignor’s entire right, title and interest in and to the copyright rights identified on Schedule A.2 (attached hereto) together with all other material created with respect thereto, including without limitation, all those reproduction and allied rights necessary and appropriate for production, distribution and exploitation in all media throughout the world in perpetuity (the “**Work**”). This assignment includes all documents, system descriptions and manuals, designs, all ideas, text, layouts, flow charts, illustrations, variations, updates, indices, appendices, editorial contributions and other information, and any other elements of the Work, developed or contributed by Assignor, alone or with others, and all copyrights therein, and all renewals and extensions of such copyrights, and any translations, versions and other adaptations or revisions of the Work, now made or hereafter created. Assignor represents and warrants that the Work is original and was created by Assignor, and that to its knowledge the Work does not violate the rights of any third party.

3. Transfer of Domain Name. Assignor hereby transfers to Assignee all right, title and interest in and to all rights in the domain names “www.schaafsma.com” (the “**Domain Name**”), including but not limited to all trademark, service mark and trade name rights in the Domain Name, and all copyright interests throughout the world in the Domain Name, if any, and any other proprietary rights associated with the Domain Name.



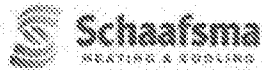

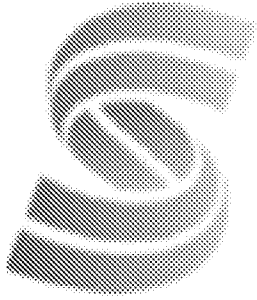
