IP SUPPLEMENT


This IP SUPPLEMENT, dated as of March 31, 2021 delivered pursuant to and supplements (i) the First Lien Security Agreement dated as of April 29, 2019 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “**Security Agreement**”), by and among Sorenson Communications, LLC, a Utah limited liability company, each of the other Loan Parties party thereto, each additional grantor party thereto and Credit Suisse AG, Cayman Islands Branch, as the Collateral Agent (the “**Collateral Agent**”) and (ii) the First Lien Trademark Security Agreement dated as of April 29, 2019 (the “**Trademark Agreement**”) executed by Sorenson Communications, LLC, CaptionCall, LLC, InteractiveCare, LLC and the Collateral Agent. Capitalized terms used herein and not otherwise defined herein shall have the meanings ascribed thereto in the Security Agreement.

Sorenson Communications, LLC and CaptionCall, LLC (each a “**Trademark Grantor**”) each grant to the Collateral Agent (for the benefit of the Secured Parties) a security interest in all of each Trademark Grantor’s right, title and interest in and to the Trademark Collateral (as defined in the Trademark Agreement) set forth on Schedule A annexed hereto. All such Trademark Collateral shall be deemed to be part of the Trademark Collateral and shall be hereafter subject to each of the terms and conditions of the Security Agreement and the Trademark Agreement.
