**RELEASE OF SECURITY INTEREST IN  
TRADEMARK COLLATERAL**

This RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL (the "Release"), dated as of April 26, 2021, is made by WELLS FARGO BANK, NATIONAL ASSOCIATION, as collateral agent (the "Agent") in favor of MIDWEST GAMING & ENTERTAINMENT, LLC, (the "Grantor").

**WITNESSETH**

WHEREAS, the Grantor entered into that certain Revolving Credit and Term Loan Agreement, dated as of December 15, 2016 (as amended by that certain First Amendment to Revolving Credit and Term Loan Agreement, dated as of October 31, 2018 and as further amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), by and among the Grantor, the banks, financial institutions and other entities from time to time party thereto in the capacity of lenders, and Wells Fargo Bank, National Association, as administrative agent;

WHEREAS, pursuant to the Credit Amendment, the Grantor executed the Amended and Restated Grant of Trademark Security Interest, dated as of March 6, 2019 (the "Trademark Security Agreement") and recorded with the U.S. Patent and Trademark Office on May 17, 2019 at Reel/Frame No. 6648/0607, pursuant to which the Grantor granted to the Agent a security interest in all of their right, title and interest in and to the Trademark Collateral (as defined in the Trademark Security Agreement).


WHEREAS, the Grantor has requested that the Agent release its security interest in all of its right, title and interest in and to the Trademark Collateral.

The undersigned hereby transfers and assigns to the Grantor, without recourse, representation or warranty of any kind or nature, any and all right, title and interest that the Agent may have obtained in and to all of its Trademark Collateral under the Trademark Security Agreement.


