Pursuant to Section 251 of the General Corporation Law of the State of Delaware, Project Carbon Merger Sub 2, Inc., a Delaware corporation, does hereby certify as follows relating to the merger of Collective Medical Technologies, Inc. with and into Project Carbon Merger Sub 2, Inc. (the “**Merger**”):

**FIRST:** The name and state of incorporation of the constituent corporations are: (a) Collective Medical Technologies, Inc., a corporation duly organized and existing under the laws of the State of Delaware, and (b) Project Carbon Merger Sub 2, Inc., a corporation duly organized and existing under the laws of the State of Delaware (collectively, the “**Constituent Corporations**”).

**SECOND:** An Agreement and Plan of Merger, dated as of December 15, 2020 (the “**Merger Agreement**”), by and among PointClickCare Corp., a corporation organized under the laws of Ontario (“**Parent**”), the Constituent Corporations, Project Carbon Merger Sub 1, Inc., a direct wholly owned subsidiary of Parent, and the Securityholder Representative (as defined in the Merger Agreement), has been approved, adopted, executed and acknowledged by each of the Constituent Corporations in accordance with Section 251 and Section 228 of the Delaware General Corporation Law.

**THIRD:** The surviving corporation shall be Project Carbon Merger Sub 2, Inc. and the name of the surviving corporation (the “**Surviving Corporation**”) is “Project Carbon Merger Sub 2, Inc.” Upon the Merger becoming effective, the name of the Surviving Corporation shall be changed to “Collective Medical Technologies, Inc.”

**FOURTH:** The Certificate of Incorporation of Project Carbon Merger Sub 2, Inc., as now in force and effect, shall continue to be the Certificate of Incorporation of the Surviving Corporation (except as set forth in Article THIRD hereof, which shall control), until amended and changed pursuant to the provisions of the General Corporation Law of the State of Delaware.

**FIFTH:** The Merger shall become effective upon the filing of this Certificate of Merger with the Secretary of State of the State of Delaware.

SIXTH: An executed copy of the Merger Agreement is on file at the principal place of business of the Surviving Corporation at the following address: c/o PointClickCare Corp., 5570 Explorer Drive, Mississauga, Ontario, L4W 0C4.

SEVENTH: An executed copy of the Merger Agreement will be furnished by the Surviving Corporation, on request and without cost, to any stockholder of either Constituent Corporation.
