## TRADEMARK ASSIGNMENT AGREEMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT (this “Assignment Agreement”), effective as of December 21, 2020 (the “Effective Date”), is made and entered into by and among Daybreak Game Company LLC, a Delaware limited liability company, located at 13500 Evening Creek Drive N., Suite 300, San Diego, CA 92128 (“ASSIGNOR”), and Cold Iron Studios LLC, a Delaware limited liability company (“ASSIGNEE”).

WHEREAS, ASSIGNOR is the owner of the applications identified in Schedule A (the “Trademarks”);

WHEREAS, ASSIGNOR desires to transfer all rights, title and interest in and to the Trademarks to ASSIGNEE;

WHEREAS, ASSIGNEE desires to acquire all of ASSIGNOR’s rights, title and interest in and to the Trademarks;

WHEREAS, ASSIGNEE is the successor to the ASSIGNOR’s entire business including the portion thereof to which the Trademarks pertain via that particular ASSIGNMENT AND ASSUMPTION AGREEMENT dated December 21, 2020.

NOW, THEREFORE, for good and valuable consideration, the receipt, adequacy and legal sufficiency of which is hereby acknowledged, ASSIGNOR does hereby irrevocably sell, assign, grant and transfer to ASSIGNEE, its entire worldwide right, title and interest in and to the Trademarks, including all common law rights, along with the goodwill of the business symbolized by the Trademarks, the same to be held and enjoyed by ASSIGNEE for its own use and enjoyment and the use and enjoyment of its successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by ASSIGNOR if this assignment had not been made, as assignee of its entire right, title and interest therein, and the right to sue, counterclaim, and recover for past, present and future infringement of the rights assigned or to be assigned under this Assignment Agreement. The Trademarks are being assigned as part of the entire business or portion thereof to which the Trademarks pertain as required by Section 10 of the Trademark Act, 15 U.S.C. § 1060.

This Assignment Agreement may be executed in one or more counterparts, each of which shall be deemed to be an original, but all of which together shall constitute one and the same instrument.




