ASSIGNMENT AGREEMENT

The Assignor declares that it has full right and lawful authority to sell and convey the same in the manner herein set forth.

The Assignor shall communicate to the Assignee, or its representatives, any facts known respecting the Mark, and to testify in any legal proceedings, sign all lawful papers, execute all applications, execute all necessary assignment papers to cause any and all trademarks directed to the Mark to be issued to the Assignee, to make all rightful oaths, and to generally do everything possible to aid the Assignee, and its successors and assigns, to obtain and enforce proper protection for the Mark in the United States and in any and all foreign countries.
