**TERMINATION AND RELEASE OF SECURITY INTEREST**

**THIS TERMINATION AND RELEASE OF SECURITY INTEREST** (this "Release") is granted as of this 7th day of May 2021, by **BANK OF AMERICA, N.A.** ("Secured Party") in favor of **GIBBS & COX, INC.**, a New York corporation ("Grantor").

**WHEREAS**, pursuant to that certain Grant of Security Interest, dated December 23, 2020 (the "Security Agreement"), Grantor granted to Secured Party a security interest in the United States trademarks described on **Exhibit A** attached hereto (the "Trademarks"), together with the goodwill of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof (the "Collateral"); and

**WHEREAS**, the Grant of Security Interest was recorded in the Trademark division of the United States Patent and Trademark Office on January 29, 2021 at Reel 7173, Frame 0532, against the Trademarks identified on **Exhibit A** hereto; and


**WHEREAS**, Secured Party has agreed to release its security interest in the Trademarks and all Collateral.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties, intending to be legally bound, the Secured Party hereby agrees as follows:

1. Secured Party does hereby (i) release the continuing security interest and continuing lien upon, and terminates its security interest in, and all other rights, title and interest in and to, the Trademarks and Collateral, without any recourse, representation or warranty, (ii) terminates the Security Agreement, and (iii) re-assigns to Grantor, any right, title or interest Secured Party may have in, to or under the Trademarks or Collateral, together with the goodwill of the business symbolized thereby, and hereby authorizes Grantor or Grantor's authorized representative or designee to record this Release with the United States Patent and Trademark Office as evidence of such release and termination.

2. This Release shall be governed by and construed in accordance with the laws of the State of New York.
