## Assignment of Intellectual Property

This Assignment of Intellectual Property ("Assignment"), effective as of the 24th day of February, 2021 ("Effective Date"), is by and between Antonino G. Secchi, DMD, MS ("Assignor"), and CCO Licensing LLC, a Pennsylvania limited liability company ("Assignee").

1. Assignment of Rights. Assignor hereby irrevocably grants, sells, conveys, assigns, transfers and delivers to Assignee, its successors and assigns, all of Assignor's right, title and interest in and to the Brand, together with all translations, adaptations, and derivations thereof, and including all goodwill of the business associated therewith.
2. Assignee's Rights. Assignee may use the Brand in connection with providing its goods and services and take all actions to enforce its rights in the Brand as of the Effective Date.
3. Binding Effect. This Assignment shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors, permitted assigns, heirs, beneficiaries, and affiliates including partners, officers, directors, parents, and subsidiaries.
4. Governing Law. This Assignment may be executed in counterparts, each of which shall be deemed an original and all of which shall constitute one and the same instrument and shall be governed by, and construed in accordance with, the laws of the Commonwealth of Pennsylvania.
