TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of May 10, 2021 (the “Effective Date”), is made by LAKE CITY BANK, in its capacity as the secured party (the “Secured Party”), in favor of the owner identified on Schedule A attached hereto (the “Grantor”).

WHEREAS, Grantor has granted a security interest in certain personal property to the Secured Party, including without limitation a security interest in certain trademarks, trademark applications, and/or trademark licenses (“Trademarks”);

WHEREAS, the security interest granted to the Secured Party was recorded with the United States Patent and Trademark Office on October 21, 2016 at Reel/Frame 5905/0301; and

WHEREAS, the Secured Party has agreed to terminate and release its security interest in any of the Grantor’s Trademarks.


NOW, THEREFORE, for valuable consideration, the Secured Party hereby terminates and releases liens and security interests granted to the Secured Party in any of the Grantor’s Trademarks, including the following:

1. Release. The Secured Party, without representation or warranty of any kind, hereby releases, discharges, terminates and cancels all of its security interest in and to the collateral, including the trademark registrations and applications set forth Schedule A attached hereto.
2. Further Assurances. The Secured Party agrees to take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor, at the Grantor’s sole cost and expense, to more fully and effectively effectuate the purposes of this Release.
3. Governing Law. This Release shall be governed exclusively under the laws of the state of New York, without regard to conflicts of law or choice of law principles.
