USA - TRADEMARK DEED OF ASSIGNMENT

WHEREAS, ASSIGNEE is desirous of acquiring any and all of ASSIGNOR's rights, title and interest in and to the Mark, the U.S. registration thereof, Reg. No. 3605175, together with the goodwill of the business connected with the use of or symbolized by said trademark, and the right to all claims against third parties for damage and compensation relating to or arising from the past, current, or future use and registration of said trademark, with the right to sue for and collect the same; and

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, said ASSIGNOR does hereby transfer, convey and assign unto ASSIGNEE and ASSIGNEE hereby accepts any and all of ASSIGNOR's rights, title and interest in and to the Mark, the U.S. registration thereof, Reg. No. 3605175, together with the goodwill of the business connected with the use of or symbolized by said trademark, and the right to all claims against third parties for damage and compensation relating to or arising from the past, current, or future use and registration of said trademark, with the right to sue for and collect the same.

ASSIGNOR further agrees to execute any other or further documents which may be reasonably necessary for the protection or perfection of any right, title, or interest herein acquired by ASSIGNEE.
