**TERMINATION AND RELEASE OF
SECOND LIEN SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Second Lien Security Interest in Trademarks (“Release”) is made as of May 14, 2021, by **MORGAN STANLEY SENIOR FUNDING, INC.**, as Collateral Agent (“Collateral Agent”) in favor of **USIC LOCATING SERVICES, LLC**, an Indiana limited liability company, and **BLOOD HOUND, LLC**, a Delaware limited liability company (each a “Grantor” and collectively, the “Grantors”).

WITNESSETH:

WHEREAS, **USIC LOCATING SERVICES, LLC** and **BLOOD HOUND, LLC** entered into that certain second lien trademark security agreement dated August 19, 2017 (the “Trademark Security Agreement”) with Collateral Agent, notice of which was recorded on August 21, 2017 at the United States Patent and Trademark Office at Reel 6134, Frame 0527.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, each Grantor granted the Collateral Agent, under the terms of the Trademark Security Agreement, a security interest (the “Security Interest”) in favor of the Collateral Agent, in all of its right, title and interest in or to all of the Owned Trademarks included in the Collateral, including without limitation the trademarks listed in **Schedule A** attached hereto (collectively, the “Trademark Collateral”).

WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges any and all of its interest in the Trademark Collateral of each Grantor, and assigns, transfers and conveys to such Grantor any interest in such Trademark Collateral.
