RELEASE OF TRADEMARK SECURITY INTEREST

This **RELEASE OF TRADEMARK SECURITY INTEREST** (this "Release") is dated as of May 14, 2021 by **BMO HARRIS BANK, N.A.**, a national banking association, as administrative agent (the "Administrative Agent"), in favor of **DULUTH HOLDINGS INC.**, a Wisconsin corporation ("Grantor"). All capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement (as defined below) and/or the Credit Agreement (as defined below).

WHEREAS, pursuant to that certain Credit Agreement dated as of May 17, 2018, as amended by that certain Amendment Number One to Credit Agreement dated as of April 30, 2020 (as amended, supplemented, amended and restated or otherwise modified from time to time, the "Credit Agreement") among **DULUTH HOLDINGS, INC.**, a Wisconsin corporation (the "Borrower"), the various financial institutions as are or may become parties hereto (collectively, the "Lenders") and **BMO HARRIS BANK, N.A.**, a national banking association ("BMO"), as Administrative Agent, Swingline Lender and L/C Issuer for the Lenders, have extended Commitments to make Loans to or for the account of the Borrower; and

WHEREAS, in connection with the Credit Agreement, the Grantor is a party to, and "Grantor" under, the General Security Agreement, dated as of May 17, 2018 (as amended, supplemented, amended and restated or otherwise modified from time to time, the "Security Agreement");

WHEREAS, pursuant to the Credit Agreement, Grantor executed that certain Notice of Grant of Security Interest in Trademarks, dated as of May 17, 2018 (including all schedules thereto, as from time to time amended, restated, amended and restated or otherwise modified from time to time, the "Trademark Security Agreement");

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on May 17, 2018 at Reel 006394, Frame 0218; and


WHEREAS, the Administrative Agent desires to release any and all security interest it has in any of the following (collectively, the "Released Collateral"): (i) Trademark Collateral, and (ii) Trademarks set forth on Schedule I hereto.

NOW, THEREFORE, for and in consideration of the foregoing, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby (i) terminates the Trademark Security Agreement and (ii) terminates, releases and forever discharges the security interest and any and all other rights granted to it with respect to the Released Collateral. Administrative Agent hereby authorizes the Grantor to file this Release with the United States Patent and Trademark Office.
