RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of May 14, 2021 (the “Effective Date”), is made by BRIGHTWOOD LOAN SERVICES LLC, as Collateral Agent (the “Collateral Agent”) for the Secured Parties, in favor of AUTHORITY BRANDS, LLC, THE CLEANING AUTHORITY, LLC, and HOMEWATCH CAREGIVERS, LLC (each a “Grantor” and collectively, the “Grantors”). All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed to them in the Trademark Security Agreement (whether defined therein or by reference to another agreement).

WHEREAS, pursuant to that certain Security Agreement, dated as of September 21, 2018 in favor of Collateral Agent (as may have been amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”), the Grantors executed and delivered that certain Trademark Security Agreement (Intellectual Property Security Agreement), dated as of September 21, 2021 (the “Trademark Security Agreement”), which was recorded in the United States Patent and Trademark Office (“USPTO”) on September 21, 2018 at Reel/Frame 6442/0549 (with respect to Authority Brands), at Reel/Frame 6466/0581 (with respect to The Cleaning Authority), and at Reel/Frame 6442/0594 (with respect to Homewatch Caregivers);

WHEREAS, pursuant to the Security Agreement and the Trademark Security Agreement, each Grantor granted to the Collateral Agent for the benefit of the Secured Parties a security interest (the “Security Interest”) in all of such Grantor’s right, title and interest in and to the registered Trademarks and Trademarks for which applications are pending in the USPTO set forth on Schedule A hereto, but excluding any Excluded Property (the “Trademark Collateral”); and

WHEREAS, the Collateral Agent and the Grantors acknowledge that the requirements for releasing the Security Interest in the Trademark Collateral have been met.


NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent, hereby (a) terminates and cancels the Trademark Security Agreement, (b) releases, discharges, terminates and cancels the Security Interest in the Trademark Collateral, and (c) re-assigns to each Grantor any right, title or interest it may have in the Trademark Collateral of such Grantor, in each case without recourse to the Collateral Agent and without representation or warranty of any kind.


Each Grantor, or any successor to such Grantor (including any person or entity hereafter having any right, title or interest in or to the Trademark Collateral of such Grantor), is hereby authorized to record this Release in the USPTO.


