**TERMINATION AND RELEASE OF SECURITY INTEREST IN
PATENTS AND TRADEMARKS**

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN PATENTS AND TRADEMARKS (this "Termination and Release") is made as of this 17th day of May, 2021, and filed pursuant to and in accordance with that certain payoff letter, dated as of May 17, 2021 and attached hereto as Exhibit A (the "Payoff Letter").

WHEREAS, pursuant to the Security Agreement dated as of February 28, 2019, made by the New Aqua, LLC ("Debtor") in favor of the First Merchants Bank (the "Secured Party" and such agreement, the "Security Agreement"), a lien on and security interest in certain Patents and Trademarks (as defined in the Security Agreement) was granted by Debtor to the Secured Party (the "Security Interest");

WHEREAS, the Security Agreement was recorded in the United States Patent and Trademark Office; and

WHEREAS, the Secured Party has been paid in full, the Security Agreement has terminated pursuant to the terms of the Payoff Letter, and the Secured Party has authorized the termination of the Security Interest in accordance with the Payoff Letter;

NOW, THEREFORE, FOR GOOD AND VALUABLE CONSIDERATION, including the satisfaction of all obligations, indebtedness and liabilities secured by the Patents and Trademarks pursuant to the Security Agreement and upon the terms set forth in this Termination and Release, as authorized under the Payoff Letter:

1. Release of Security Interest. The Security Agreement is terminated in accordance with the Payoff Letter and the Security Interest is terminated, released and discharged and all right, title and interest in the Patents and Trademarks is reassigned to the person or persons legally entitled thereto.

Mr. Ackerman:

Reference is made to that certain (a) Term Loan Promissory Note, dated February 28, 2019, granted by New Aqua, LLC (the "Company") in favor of First Merchants Bank ("Lender" and such loan the "Term Loan") and (b) Revolving Line of Credit Promissory Note, dated February 28, 2019, granted by the Company in favor of Lender (the "Revolver"), each of (a) and (b) issued pursuant to that certain Credit Agreement, dated February 28, 2019, by and between the Company and Lender, (the "Credit Agreement") as secured by that certain Security Agreement, dated February 28, 2019, by and between the Company and Lender (the "Security Agreement", and collectively with the Term Loan, the Revolver and the Credit Agreement the "Loan Documents").

The Company has advised Lender that the Company intends to repay in full the indebtedness and other obligations of the Company to the Lender under the Loan Documents on or about May 17, 2021.

Lender hereby confirms that, upon Lender's receipt from the Company of the aggregate amount of (i) \$5,096,441.72 plus, for each day after May 17, 2021, a per diem amount equal to \$298.446622234 in satisfaction of the Term Loan and (ii) \$5,782,106.73 plus, for each day after May 17, 2021, a per diem amount equal to \$338.650784346 in satisfaction of the Revolver, in each case, rounded up to the nearest \$.01 cent, in immediately available funds in accordance with the respective wire transfer instructions set forth on Exhibit A, (a) all indebtedness, liabilities and obligations of any kind, whether fixed or contingent, of the Company owing to Lender under the Loan Documents and all amounts due thereunder shall be satisfied and paid in full, (b) the commitments of Lender and the Company under the Loan Documents shall be terminated, (c) the Loan Documents and all agreements, documents, guarantees or instruments related thereto shall be automatically terminated and of no further force or effect without any further liability to the Company or any of its affiliates, (d) the Lender shall execute such other documents and instruments and take such other actions as the Company shall reasonably request to evidence the satisfaction of the Company's obligations to the Lender and (e) any and all security interests and liens on collateral securing the Loan Documents shall be automatically terminated, discharged and released in full, and Lender expressly permits the Company's counsel, Ice Miller LLP as well as Barnes & Thornburg LLP (as counsel for the purchaser of the Company upon the payoff of the Loan Documents) to file any UCC termination statements and any terminations of intellectual property security interests so required to effect such terminations.¹

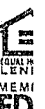
