Pursuant to *Utah Code Annotated* § 48-3a-1025, the undersigned parties of the merger execute and deliver the following Statement of Merger:

## ARTICLE 1 NON-SURVIVING CORPORATION

The non-surviving entity is American Equipment, Inc., a Utah corporation organized on 19 March 1973.

## ARTICLE 2 SURVIVING LIMITED LIABILITY COMPANY

The entity surviving the merger is American Crane Group, LLC, which shall hereafter be named and known as American Equipment, LLC, such name having changed as a result of the merger. The surviving limited liability company is a domestic limited liability company organized under the laws of the State of Utah as entity number 8863108-0160.

## ARTICLE 3 APPROVAL

The merger was approved in accordance with *Utah Code Ann.* §§ 16-10a-1101 through 16-10a-1106 and 48-3a-1021 through 48-3a-1026. A Plan of Merger of American Equipment, Inc. into American Crane Group, LLC was executed by all members of American Crane Group, LLC and the President of American Equipment, Inc. Pursuant to *Utah Code Ann.* §§ 16-10a-1103 and 16-10a-1104, no vote of shareholders was required with respect to the merger.

## ARTICLE 4 SURVIVING ENTITY EXISTENCE

The surviving entity existed before this Statement of Merger. An Amended and Restated Certificate of Organization changing the name of the surviving entity is attached hereto.

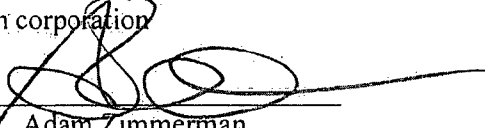

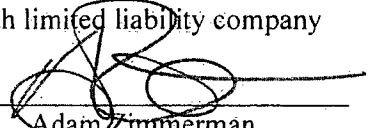

1. *Initial Articles of Organization.* The initial Articles of Organization for American Crane Group, LLC were filed on 21 November 2013.

4. *Registered Agent.* The name of the registered agent, who is a noncommercial registered agent as described in Utah Code Ann. § 16-17-203, remains as follows:

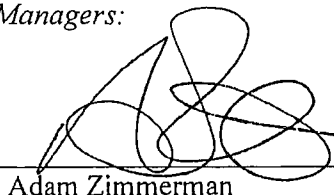

5. *Management Structure.* The Company remains a manager-managed limited liability company.

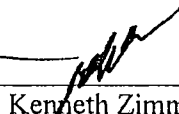
