RELEASE OF SECURITY INTERESTS IN INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTERESTS IN INTELLECTUAL PROPERTY ("Release") is made as of this 21st day of May, 2021, by CADENCE BANK, N.A. ("Lender"), in favor of Behavior Frontiers, LLC, a California limited liability company ("Behavior") and PRIORCARE, LLC, a Delaware limited liability company ("PrioraCare"; and together with Behavior, each a "Company" and collectively, the "Companies"). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement (as defined below) and the Guarantee and Collateral Agreement (as defined in the Security Agreement), as applicable.

WHEREAS, in connection with the Guarantee and Collateral Agreement, the Companies executed that certain Intellectual Property Security Agreement dated as of September 29, 2020 (the "Security Agreement"), pursuant to which each Company granted a security interest to Lender in certain Intellectual Property Collateral as security for certain obligations owing by the Companies to Lender, including the Trademarks set forth on Schedule A hereto;

WHEREAS, the Security Agreement was recorded by the United States Patent and Trademark Office on September 29, 2020, at Reel 7065, Frame 0472; and

WHEREAS, the Companies have requested that Lender release its security interest in the Intellectual Property Collateral and reassign any and all rights in the same to the Companies.

NOW THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, Lender hereby releases all liens and security interests granted by Company in favor of Lender in the Intellectual Property Collateral, including the trademarks and trademark applications listed on Schedule A attached hereto. Lender hereby reassigns, transfers, grants and conveys to the Companies any and all of Lender's right, title and interest in and to the Intellectual Property Collateral.
