PARTIES

- (1)** NUNO ALEXANDRE DA SILVA LOPES VIEIRA, an individual residing in Vila Nova de Gaia, Portugal, with the tax id number (NIF) 218663579 (**Assignor**).
- (2)** LAHC UK 1 LTD, incorporated and registered in England and Wales with company number 13349449, whose registered office is at 22 Chancery Lane, London WC2A 1LS, United Kingdom (**Assignee**).

BACKGROUND

(A) The Assignor is the proprietor of the registered trade marks set out in the Schedule to this Agreement (the **Trade Marks**)

(B) By a Business Transfer Agreement dated 20 May 2021 between the Assignor and the Assignee, the Assignor has agreed to assign the Trade Marks to the Assignee.

1. ASSIGNMENT

Pursuant to and for the consideration set out in the Business Transfer Agreement (receipt of which the Assignor expressly acknowledges), the Assignor hereby assigns to the Assignee with full title guarantee all its right, title and interest in and to the Trade Marks, together with the goodwill of the business relating to the goods in respect of which the Trade Marks are registered or used together with the right to bring, make, oppose, defend, appeal proceedings, claims or actions and obtain relief (and to retain any damages or profits recovered) in respect of any infringement, or any other cause of action (including passing off) arising from ownership, of any of the Trade Marks whether occurring before, on or after the date of this agreement.

2. VAT

All payments made by the Assignee under this agreement are exclusive of VAT. If any such payment constitutes the whole or any part of the consideration for a taxable or deemed taxable supply by the Assignor, the Assignee shall increase that payment by an amount equal to the VAT which is chargeable in respect of the taxable or deemed taxable supply,

3. FURTHER ASSURANCE

The Assignor shall at the direction and expense of the Assignee promptly execute and deliver such documents and perform such acts as may reasonably be required for the purpose of giving full effect to this agreement.

4. THIRD PARTIES

This agreement does not create any rights enforceable by any person not a party to it.

5. GOVERNING LAW & JURISDICTION

This agreement and any dispute or claim (including non-contractual disputes or claims) arising out of or in connection with it or its subject matter or formation shall be governed by and construed in accordance with the law of England and Wales. Each party irrevocably agrees that the courts of England and Wales shall have exclusive jurisdiction to settle any dispute or claim (including non-contractual disputes or claims) arising out of or in connection with this agreement or its subject matter or formation.
