ASSIGNMENT OF INTELLECTUAL PROPERTY

This Assignment of Intellectual Property is entered into as of May 20, 2021 (“Effective Date”) by and between Ted’s Bulletin Operating, LLC, a District of Columbia limited liability company (“Assignor”), and Ted’s Bulletin Holdings, LLC, a Delaware limited liability company (“Assignee”).

Assignor hereby conveys, transfers, and assigns to Assignee, as the successor to the portion of the ongoing and existing business to which the Mark pertains, all right, title, and interest in and to the Mark, including but not limited to all common law rights in the Mark and registrations for the Mark, together with the goodwill of Assignor’s business connected with the use of and symbolized by the Mark, and all rights corresponding thereto throughout the world. Assignor further assigns to Assignee all rights to sue for and receive all damages occurring from past infringing uses of the Mark.

Assignor agrees that at any time and from time to time after execution of this assignment, at the request of Assignee and without further consideration, Assignor will execute and deliver such other instruments and take such action as Assignee may reasonably request to transfer, convey, and assign to Assignee, and to confirm Assignee’s right, title, and interest in and to the Mark, and to assist Assignee in exercising all rights with respect to the Mark.

Nothing in this assignment, express or implied, is intended or will be construed to confer upon, or give to, any person or entity, other than the parties to this assignment, any rights, remedies, obligations, or liabilities. This assignment will bind and inure to Assignee and Assignor and their respective successors and assigns. This assignment may be executed in any number of counterparts, each of which will be deemed an original, but all of which together will constitute one and the same.

IN WITNESS WHEREOF, the undersigned parties have executed this transfer and assignment by and through their properly authorized signatories effective as of the Effective Date.


