ASSIGNMENT OF TRADEMARK AGREEMENT

This ASSIGNMENT OF TRADEMARK AGREEMENT (this "Assignment"), effective as of April 30, 2021, is between Justice Products, Inc. ("Seller") and Torginol, Inc. ("Buyer").

Seller, Buyer and the Majority Shareholder have entered into an Asset Purchase Agreement dated April 22, 2021, (the "APA"), pursuant to which, among other things, Seller has agreed to assign the Trademark (as defined below) to Buyer.

1. Trademark. "Trademark" means the word mark JUSTCRETE, for use with "cementitious plaster", with a United States Patent and Trademark Office ("USPTO") US Serial Number of 87615392.

2. Assignment. Seller hereby irrevocably conveys, transfers and assigns to Buyer, and Buyer hereby accepts, all of Seller's right, title and interest in and to the Trademark, together with the goodwill (if any) symbolized by the Trademark.

3. Recordation and Further Actions. Seller authorizes the Commissioner for Trademarks and any other governmental officials to record and register this Assignment upon request by Buyer. Seller shall take such steps and actions following the date hereof, including the execution of any documents, files, registrations, or other similar items, to ensure that the Trademark is properly assigned to Buyer, or any assignee or successor thereto.


