WHEREAS, all of Borrower's obligations to Lender with respect to said security agreements have been fully satisfied;


NOW, THEREFORE, Lender states as follows:

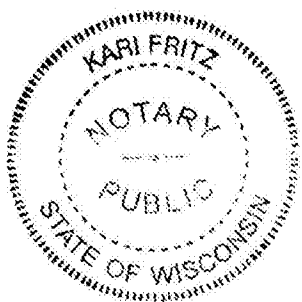


