RELEASE OF TRADEMARK SECURITY INTEREST

This RELEASE OF TRADEMARK SECURITY INTEREST is made effective as of the date of execution inscribed below by CP BF Lending, LLC, a Delaware limited liability company ("Releasor"), in favor of Prologistics Distribution, Inc., a California corporation ("Releasee").

WHEREAS, Reference is made to that certain Intellectual Property Security Agreement dated as of November 26, 2019 and recorded on December 16, 2019 at Reel 6816/Frame 0881 in the United States Patent and Trademark Office, wherein to secure the payment of certain loan obligations of Releasee, Releasee granted a security interest in and to, *inter alia*, all of Releasee's right, title and interest in and to the trademark registrations listed in the Schedule of Marks - Attachment A attached hereto (collectively, the "Trademark Collateral");

WHEREAS, Releasor has agreed to release and discharge fully its security interest in and to the Trademark Collateral and to reassign, transfer, and grant all of its right, title and interest in and to the Trademark Collateral it may have to Releasee.

1. NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Releasor hereby agrees as follows:


1. Release. Releasor, on behalf of itself and its successors, legal representatives and assigns, hereby terminates the Intellectual Property Security Agreement and terminates, fully discharges and releases in its entirety its security interest in and to the Trademark Collateral. Releasor hereby reassigns any and all such right, title and interest that it may have in the Trademark Collateral to Releasee.

2. Recordation: Further Assurances. Releasor agrees, or authorizes Releasee, to make filings with the United States Patent and Trademark Office and take further actions, as reasonably requested by Releasee to evidence the release and termination of Releasor's security interests in the Trademark Collateral.
