## RELEASE OF TRADEMARK AND COPYRIGHT SECURITY AGREEMENT

THIS RELEASE OF TRADEMARK AND COPYRIGHT SECURITY AGREEMENT ("Release"), is effective as of April 7, 2021, by and between Canadian Imperial Bank of Commerce, having an address of 40 King Street West, Suite 5702, Toronto, Ontario, Canada M5H 3Y2 as lender ("Lender") and ACL Services Ltd. ("ACL"), having an address at 9810 Howe Street, Suite 1500, Vancouver, BC, Canada V6Z 0C8, and Relational Security Corporation ("RSC"), having an address at 700 Plaza Drive, Suite R-2, Secaucus, NJ 07094. ACL and RSC are jointly referred to herein as "Borrowers".

### WITNESSETH:

WHEREAS, Lender and Borrowers entered into that certain Credit Agreement dated as of November 13, 2018 (the "Credit Agreement"), and an amended and restated credit agreement made as of January 31, 2019, as amended by a first amendment to amended and restated credit agreement dated August 30, 2019, a second amendment to amended and restated credit agreement dated May 29, 2020 and a third amendment to amended and restated credit agreement dated November 13, 2020; and

WHEREAS, pursuant to the Credit Agreement, Borrowers granted a security interest in and to all of Borrowers' intellectual property rights (among other rights) as collateral security for the payment and performance of the obligations under the Credit Agreement; and

WHEREAS, Lender and ACL are parties to that certain Intellectual Property Security Agreement dated November 13, 2018 recorded with the United States Patent and Trademark Office on December 13, 2018 at Reel/Frame 6499/0576 (the "IP Security Agreement") against all of the Borrower's right, title and interest throughout the world in and to the Collateral (as defined in the IP Security Agreement), including, without limitation, the trademark assets identified in **Schedule A** hereto ("ACL Trademarks"); and

WHEREAS, Lender and RSC are parties to that certain Intellectual Property Security Agreement dated January 31, 2019 recorded with the United States Patent and Trademark Office on January 31, 2019 at Reel/Frame 6546/0357 against all of the Borrower's right, title and interest in and to its Intellectual Property (as defined in that certain Pledge and Security Agreement (US) dated as of January 31, 2019 between Lender, RSC and certain other borrowers (the "Security Agreement")), including, without limitation, the trademark asset identified in **Schedule B** hereto ("RSC Trademarks") and recorded with the United States Copyright Office on February 1, 2019 at Document Number V9970D725 against all of the Borrower's right, title and interest in and to its Intellectual Property (as defined in the Security Agreement), including, without limitation, the copyright assets identified on **Schedule C** hereto ("RSC Copyrights", and together with the ACL Trademarks and the RSC Trademarks, "IP Collateral"); and

WHEREAS, the Lender now desires to terminate and release the entirety of its security interest in the IP Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, it is agreed that:


1. Definitions. Capitalized terms not defined herein shall have the meanings set forth in the Credit Agreement.
2. Release of Security Interest. The Lender, without representation, warranty or recourse, hereby unconditionally and irrevocably terminates, releases, cancels and discharges any and all pledges, grants, liens and security interest in, to or on the IP Collateral, and any and all right, title or interest of Lender in or to such IP Collateral shall hereby cease and become void.


3. Recordation. The Lender authorizes Borrowers and their designees to record this Release with the United States Patent and Trademark Office or any other applicable governmental authority at Borrowers' expense.
