LifeBrands Holdings Inc., formerly SoClean Holdings Inc., hereby requests the ownership information in this subject trademark application be amended to correct a clerical error. Specifically, at the time of filing on February 19<sup>th</sup>, 2020, Applicant believed a name change from SoClean Holdings Inc. to Lifebrands Inc. was previously effectuated at the Delaware Secretary of State's Office and therefore filed this subject application in the name of Lifebrands Inc. However, it has come to Applicant's attention that the name change was not recorded until April 29<sup>th</sup> 2020. Therefore, at the time of filing, the Applicant was still SoClean Holdings, Inc. but mistakenly identified itself as Lifebrands Inc.

As the correct owner filed but identified itself incorrectly, these errors are correctable. See TMEP §1201.02(c).

Therefore, Applicant herein requests the name change be effectuated to show SoClean Holdings Inc. as the owner. Once this change is recorded, Applicant will file a second Change of Name with ETAS to effectuate the change from SoClean Holdings Inc. to LifeBrands Holdings Inc.

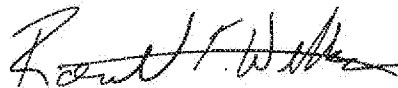
1. The name of the corporation (hereinafter called the "Corporation") is SOCLEAN HOLDINGS, INC.
