ASSIGNMENT OF GRANT OF SECURITY INTEREST IN TRADEMARKS

THIS ASSIGNMENT OF GRANT OF SECURITY INTEREST IN TRADEMARKS (the "Assignment") is made and entered into as of June 9, 2021 by BANK OF AMERICA, N.A., as the resigning Administrative Agent (in such capacity, "Assignor"), in favor of ACQUIOM AGENCY SERVICES LLC, as successor co-Administrative Agent (in such capacity, "Assignee").

W I T N E S S E T H

WHEREAS, Assignor is party to that certain Amended and Restated Security and Pledge Agreement, dated as of August 30, 2017 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"), among Protect America, Inc. ("PAI") and PAI Intermediate, Inc. ("PAI Intermediate" and, together with PAI, the "Borrowers"), as borrowers, the other grantors party thereto, and Assignor;

WHEREAS, pursuant to (i) the Security Agreement and (ii) the Notice of Grant of Security Interest in Trademarks, made by PAI in favor of Assignor, which was recorded at the United States Patent and Trademark Office on August 31, 2017, at Reel/Frame 6143/0574 (as amended, restated, supplemented or otherwise modified from time to time, the "Trademark Security Agreement"), PAI has granted to Assignor a continuing security interest in, and lien on, all of its right, title and interest in, to and under the trademark and trademark applications shown on Schedule 1 of the Trademark Security Agreement (the "Trademark Collateral"), including, without limitation, those trademark and trademark applications set forth on Schedule I hereto; and

WHEREAS, pursuant to that certain Agency Resignation, Appointment and Assumption Agreement and Fifth Amendment to the Amended and Restated Credit Agreement, dated as of May 21, 2021, among the Assignor, Assignee, the Borrowers, the other loan parties party thereto, and the lenders party thereto, Assignor has resigned as Administrative Agent under the Credit Agreement and related Loan Documents (each as defined in the Security Agreement), and Assignee has assumed and succeeded to all of the rights, powers, privileges, protections, duties, and interests of Assignor as Administrative Agent thereunder; and

WHEREAS, Assignor and Assignee desire to enter into this Assignment to evidence the assignment by Assignor to Assignee of all of Assignor's right, title and interest in, to and under the Security Agreement and the Trademark Security Agreement, including, without limitation, Assignor's security interest in, and lien on, the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee hereby covenant and agree as follows:

1. Terms. Capitalized terms used in this Assignment and not otherwise defined herein shall have the meanings specified in the Security Agreement.

2. Assignment. Assignor hereby transfers, assigns, grants and conveys to Assignee for the ratable benefit of the Secured Parties all of its right, title and interest in, to and under the Security Agreement and the Trademark Security Agreement, including, without limitation, its security interest in, and lien on, the Trademark Collateral, and Assignee hereby accepts and assumes the foregoing assignment and all of such right, title, interest, security interests and liens.

3. Recordation. Effective upon the date first written above, Assignor authorizes and requests the United States Patent and Trademark Office to record Assignee as the successor Administrative Agent for the Secured Parties in the Trademark Collateral.

4. Governing Law. This Assignment shall be governed by and construed in accordance with the laws of the State of New York.


5. Counterparts. This Assignment may be executed in counterparts, each of which shall constitute an original and all of which taken together shall constitute one and the same instrument. Delivery of an executed counterpart of a signature page to this Assignment by facsimile transmission or electronic mail shall be as effective as delivery of a manually executed counterpart of this Assignment.
