RELEASE OF FIRST LIEN INTELLECTUAL PROPERTY SECURITY AGREEMENT

This **RELEASE OF FIRST LIEN INTELLECTUAL PROPERTY SECURITY AGREEMENT** (the “Release”) is made as of June 11, 2021 by CREDIT SUISSE AG, CAYMAN ISLANDS BRANCH, a company incorporated under the laws of Switzerland (Aktiengesellschaft), having its registered office at Paradeplatz 8, CH-8070 Zürich, Switzerland, registered with the commercial register of Switzerland under number CH-020.3.923.549-1, acting through its Cayman Islands Branch, having its office at Eleven Madison Avenue, New York, New York 10010, United States of America, as Collateral Agent (the “Collateral Agent”) in favor of GLOBAL KNOWLEDGE TRAINING LLC, a Delaware limited liability company, formerly Global Knowledge Network, Inc., a Delaware corporation, having an address of 9000 Regency Parkway, Suite 100, Cary, North Carolina 27518, and other Credit Parties party thereto (the “Grantor”).

WHEREAS, pursuant to that certain U.S. First Lien Pledge and Security Agreement, dated as of January 20, 2015 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the “First Lien Security Agreement”) by and among the Grantor, the Administrative Agent, and the Collateral Agent, and that certain First Lien Intellectual Property Security Agreement, dated as of January 20, 2015 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the “First Lien IP Security Agreement”) by the Grantor in favor of the Collateral Agent, Grantors granted to the Collateral Agent, for the ratable benefit of the Secured Parties, a continuing security interest in any and all right, title and interest of Grantor in and to the Additional Collateral, including, without limitation, (i) the trademark and service mark registrations and applications listed on the attached Schedule A and (ii) the copyright registrations and applications listed on the attached Schedule B;

WHEREAS, the First Lien IP Security Agreement was recorded at the United States Patent and Trademark Office (the “USPTO”) on April 2, 2015 at Reel 5490 Frame 0677 and with the United States Copyright Office (the “USCO”) on April 3, 2015 at Volume 9924 Document 712.

WHEREAS, the Grantor has requested that the Collateral Agent release, and the Collateral Agent is willing, in connection with the termination of the First Lien Credit Agreement, to release its lien on and security interest in, and any other right, title and interest of the Grantor in and to the Additional Collateral, including, without limitation, the items set forth on Schedule A and Schedule B hereto.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the First Lien Security Agreement or the First Lien IP Security Agreement.

SECTION 2. Release. The Collateral Agent, on behalf of the Secured Parties, without representation, warranty, or recourse of any kind, express or implied, hereby:

- (a) irrevocably terminates the First Lien IP Security Agreement and terminates, cancels, discharges, and releases the continuing security interest in, and any and all right, title and interest of Grantor in and to, all of the Additional Collateral, including, but not limited to, the foregoing listed on Schedule A and Schedule B attached hereto;

- (b) reassigns, grants and conveys to Grantor any and all of the Collateral Agent's right, title and interest in and to the Additional Collateral;
- (c) authorizes the recordation of this Release with the USPTO at Grantor's expense; and
- (d) authorizes the recordation of this Release with the USCO at Grantor's expense.

SECTION 3. Further Actions. The Collateral Agent agrees to take all further actions, and provide to the Grantor and their respective successors, assigns or other legal representatives, all such cooperation and assistance reasonably requested by Grantor, at the Grantor's sole cost and expense, to more fully and effectively effectuate the purpose of this Release.

SECTION 4. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of New York, without regarding to conflicts of law or choice of law principles.

SECTION 5. Electronic Signatures. This Release may be executed in any number of counterparts, all of which when taken together shall constitute one and the same agreement. Delivery of an executed signature page of this Release by electronic image scan transmission shall be effective as delivery of a manually executed counterpart hereof. Any signature to this Release may be delivered by facsimile, electronic mail (including pdf) or any electronic signature complying with the U.S. federal E-SIGN Act of 2000 or the New York Electronic Signature and Records Act or other transmission method and any counterpart so delivered shall be deemed to have been duly and validly delivered and be valid and effective for all purposes to the fullest extent permitted by applicable law. For the avoidance of doubt, the foregoing also applies to any amendment, extension or renewal of this Release. Each of the parties represents and warrants to the other parties that it has the corporate (or similar) capacity and authority to execute this Release through electronic means and there are no restrictions for doing so in that party's constitutive documents.

IN WITNESS WHEREOF, the Collateral Agent, on behalf of the Secured Parties, has caused this Release of First Lien Intellectual Property Security Agreement to be duly executed as of the date first set forth above.
