**TERMINATION AND RELEASE OF
TRADEMARK SECURITY AGREEMENT**

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT dated as of June 1, 2021 (this “Release”) is made by Cadence Bank, N.A., as administrative agent (together with its successors in such capacity, the “Administrative Agent”), under that certain Notice of Grant of Security Interest in Trademarks dated as of October 22, 2019 (as amended, restated, supplemented or otherwise modified from time to time, the “Trademark Security Agreement”) by and between FlowBelow Aero, Inc., a Delaware corporation (the “Grantor”) and the Administrative Agent for the Lenders, and recorded in the records of the United States Patent and Trademark Office at Trademark Reel 6777, Frame 0339. Capitalized terms used in this Release and not otherwise defined herein have the meanings specified in the Trademark Security Agreement.

The Administrative Agent now wishes to release and terminate all right, title and interest in the Intellectual Property Collateral under the Trademark Security Agreement.

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Administrative Agent releases and terminates all right, title and interest in, to and under the Trademark Security Agreement in the Intellectual Property Collateral.
