UNITED STATES TRADEMARK SECURITY AGREEMENT

This TRADEMARK SECURITY AGREEMENT (this “**Agreement**”) dated as of July 22, 2019 is made by and between U.S. BANK NATIONAL ASSOCIATION, in its capacity as Administrative Agent (together with its successors and assigns, in such capacity, the “**Agent**”), and FIRSTLINE TRANSPORTATION SECURITY, INC., an Ohio corporation (together with its successors and permitted assigns, the “**Grantor**”).

WHEREAS, this Agreement will be filed with the United States Patent and Trademark Office to among other things indicate that Lender is collateral assignee with respect to the Trademarks (as defined herein) listed on Schedule A hereto;

WHEREAS, the Grantor is the owner of certain trademarks, including the applications and registrations thereof, together with the goodwill of the business connected with the use of and symbolized by the trademarks and all proceeds thereof, including, without limitation, any and all past, present and future causes of action which may exist by reason of infringement thereof, set forth on Schedule A hereto (collectively, the “**Trademarks**”);

WHEREAS, SMS Holdings Corporation (the “**Borrower**”), the Agent, and the other parties thereto executed a Credit Agreement, dated as of July 22, 2019 (as amended, restated, amended and restated, modified or supplemented from time to time, the “**Credit Agreement**”), pursuant to which the Agent has agreed to make certain loans and other extensions of credit to the Borrower; and

WHEREAS, the Grantor, the Agent, and the other parties thereto executed a Security Agreement, dated as of July 22, 2019 (as amended, restated, amended and restated, modified or supplemented from time to time, the “**Security Agreement**”), pursuant to which the Grantor granted and agreed to grant to Agent a security interest in certain of its assets to secure the Borrower’s obligations to the Agent and certain other lenders under the Credit Agreement.

NOW, THEREFORE, for good and valuable consideration, Grantor hereby pledges and grants (and confirms and ratifies all other pledges and grants heretofore made to the Agent) to the Agent a security interest and lien in and to the Trademarks, subject to the terms and conditions of each of the Credit Agreement and the Security Agreement.


