AFFIDAVIT OF SCOTT J. COZIAHR

RE: Purported assignment recorded on August 23, 2020, found at Reel/Frame 7031/0684

I, Scott J. Coziahr, do hereby declare that:

1. I am over the age of 18 and competent to testify to the matters set forth herein.
2. I am the Executive Vice President and General Counsel for Farm Credit Services of America, ACA. ("FCSAmerica").
3. The trademark application for FARM CREDIT SERVICES OF AMERICA was filed on December 19, 2012, with the United States Patent and Trademark Office ("USPTO"). The USPTO issued a Registration Certificate for the Mark on October 1, 2013, under registration number 4,410,166 ("Mark"). A copy of the Registration Certificate is attached hereto as Exhibit A.
4. A purported Nunc Pro Tunc Assignment was filed with the USPTO Assignment Recordation Branch by Pamela Lovett on August 23, 2020, claiming an effective date of April 18, 2013 ("Purported Assignment"). The Purported Assignment can be located at Reel/Frame 7031/0684. The Purported Assignment is attached hereto as Exhibit B.
5. As part of the Purported Assignment, it is FCSAmerica's belief that Pamela H. Lovett is attempting to assign the Mark to herself. The Cover Sheet lists the conveying party as Pamela H. Lovett and Farm Credit Services of America Incorporated, FLCA, neither of which were the owner of record as of the date of the filing. FCSAmerica is a different entity from Farm Credit Services of America Incorporated, FLCA.
6. Further, the Purported Assignment lists Farm Credit Services of America Incorporated, FLA, Pamela H. Lovett, Steven Mnuchin (Sec. of Treasury), Andrei Iancu (Director of USPTO),

Laurel Lee (Florida Secretary of State), Jeanette Nunez (Lt. Gov. of Florida), and Ashley Moody (Florida Attorney General), as the receiving parties under the Purported Assignment.

7. The document itself is titled "TRADEMARK ASSIGNMENT", but the document itself upon information and believe, does not contain the required information or language sufficient to transfer any rights in and to the Mark. For example, it does not list the existing owner/registrant, nor does it contain any information regarding the Mark or the transfer of goodwill associated with the Mark.

8. FCSAmerica did not authorize the filing of the Purported Assignment, nor did it in any way engage with any third parties for the assignment or transfer of any rights or the granting of a security interest in and to the Mark.

9. Pamela H. Lovett is not now and never has been an employee, officer, director or agent of FCSAmerica, and is not authorized to act on behalf of FCSAmerica. FCSAmerica has never entered into any transaction with Pamela H. Lovett for the transfer of the Mark.


11. From the date the application was submitted for the Mark through the date of this Affidavit, FCSAmerica has never assigned, transferred, or granted a security interest in this Mark to any third party, and FCSAmerica remains the current owner of the Mark.

10. FCSAmerica's attorney, Clint D. Cadwallader of McGrath North Mullin & Kratz, PC LLO contacted the USPTO via email shortly after I became aware of this Purported Assignment, through which Mr. Cadwallader highlighted the issues with the filing and that it was the belief of FCSAmerica and Mr. Cadwallader that this was a fraudulent filing.

11. Upon request of Mr. Cadwallader that the record be corrected to reflect proper ownership in the TSDR records based on the fact that the Purported Assignment did not fulfill the basic requirements required for an assignment to be accepted, a Note to the File was entered on September 20, 2020, to indicate that "[p]ursuant to TMEP §504.03, the ownership records have been changed manually back to the last listed owner of the above mark who had proper chain of title." The Note to the File is attached hereto as Exhibit C.

12. FCSAmerica respectfully requests this Corrective Assignment be accepted and made of record with the USPTO to ensure the assignment records are properly updated to reflect that Farm Credit Services of America, ACA is the true owner of record of the Mark.

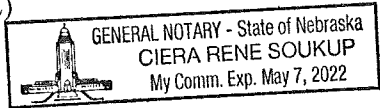

TRADEMARK ASSIGNMENT

FOR ENTIRE UNDIVIDED RIGHTS, TITLE, INTEREST, ALONG WITH THE GOODWILL OF ALL BUSINESS/AGENCY ENTITIES CONNECTED

This TRADEMARK ASSIGNMENT FOR ENTIRE UNDIVIDED RIGHTS, TITLE, INTEREST, ALONG WITH THE GOODWILL OF ALL BUSINESS/AGENCY ENTITIES CONNECTED is made and entered into as of August 14, 2020 (the "Effective Date") by and between, PAMELA H LOVETT ("Assignor"), unregistered non-human factor of production, and Pamela H. Lovett ("Assignee"), natural person from whom "Assignor" was abstracted in logical form, and would not exist at all were it not for the "Assignee" that gave existence to abstracted form.

Pamela H. Lovett, having an address at 300 East Main Street, Unit 1867, Wauchula, Florida 33873-9999, is the real and true principal owner of the unregistered non-human trade name, PAMELA H LOVETT, and is present, competent, and acting with full power and authority to do and perform every lawful act and thing that a Principal would do to secure all assets and properties of his ownership with absolute unencumbered rights, title, and interests thereto.

The economic hardship irreparably damaging the financial credibility and character of the undersigned was not brought about by any action committed directly or even indirectly by the undersigns. This was directly and expressly caused by the deceptive trade practices engineered by foreign agent intellectual property law firms, in direct collusion with the international business of banking and certain agencies of the federal government. Namely, by the uninformed and concealed fractionalization, collateralization, decomposition, securitization, and repeated rehypothecation of the undersigns unregistered capitalized trade name through patents, trademarks, copyrights, and trade secrets. Incorporated into an 'involuntary dictatorship', the undersigned was deemed an "unqualified grantor" and reduced to nothing more than a multiplicity of electronic business objects that exists only for the trafficking pleasure and profits of foreign agent law firms and those with whom they collude.

This TRADEMARK ASSIGNMENT is the Independent act of the undersigned and is the absolute and indisputable revocation of all contrived presumptions of voluntary agreement, or stated factually, all imposed pledge, guarantor, and credit security agreements, along with all incorporations by reference. The effect of which terminates all imposed foreign agent attorneys acting as nominated agents and all powers thereto whatsoever, nunc pro tunc, et al., resulting in a complete reversion.

This TRADEMARK ASSIGNMENT corrects all 'affected errors' executed through the United States Patents and Trademarks Office ("USPTO"), that demands a full and complete audit, not by the State of Florida, but by the United States Department of Treasury and federal agencies thereto connected, covering all jurisdictions, domestic and foreign. This includes but not only exclusive to an alleged mortgage loan to real property agreement with the Farm Credit Corporation, all subsidiaries, and affiliates, that includes proper and just reversion of all agreements thereto connected (see attached).

WHEREAS, Pamela H. Lovett is the owner of all rights, title, and interest in, to, and under all United States and foreign trademarks and service marks unregistered and registered, to which PAMELA H LOVETT 'is connected' in any variation of spelling and all converted digital/electronic form (pki, gmei, barcode, etc.). Capitalized meaning not defined herein, has the meaning as defined by the terms and
