ASSIGNMENT OF INTELLECTUAL PROPERTY
(Trademarks)

THIS ASSIGNMENT OF INTELLECTUAL PROPERTY ("Assignment") is effective as of the Effective Date (below), by and between the following parties:

ASSIGNOR: MICHAEL MADDEN ("Assignor"), and

ASSIGNEE: MADDEN MANUFACTURING COMPANY OF MISSOURI, a Missouri corporation ("Assignee").

WHEREAS, Assignor is the owner of certain Intellectual Property described more fully in this Assignment; and

WHEREAS, Assignee desires to acquire full ownership of such Intellectual Property under the terms and conditions of this Assignment;

NOW, THEREFORE, in consideration of the sum of Ten Dollars (\$10.00), the recitals and of the respective covenants and agreements herein contained, and other good and valuable consideration, the receipt, adequacy and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, Assignor and Assignee agree as follows:

1. Assignment. Assignor hereby assigns and transfers to Assignee, its successors and assigns, free of all encumbrances, all right, title and interest, and the goodwill of the business associated therewith, of Assignor, in the U.S. and in all foreign countries, in and to all Intellectual Property, including common law rights associated therewith, and the right to sue for past, present, and future infringement thereof, and to recover all damages therefrom for its own use and behalf and for the use and behalf of its successors and assigns or other legal representatives, and including, but not limited to, Intellectual Property specifically identified in Exhibit A (collectively referred to herein as the "IP"). The term "Intellectual Property" shall be broadly construed to include all rights relating to trademarks, service marks, rights of use and priority, trade dress, rights under common law, and copyrights.

2. Additional Assurances. Assignor agrees, at the request and expense of Assignee, to perform such proper additional acts, and to execute such additional documents as are deemed necessary by the governmental agencies having jurisdiction over the IP to effect the transfer of all of the Assignor's right, title and interest therein to Assignee, its successors and assigns. In furtherance thereof, Assignor hereby authorizes such governmental agencies to identify Assignee as the owner of all rights issuing from applications pending among such IP. Assignor further represents and warrants that it has not granted any rights inconsistent with the rights granted herein.

3. Severability. Every provision of this Assignment is intended to be severable. If any term or provision hereof is illegal or invalid for any reason whatsoever, such illegality invalidity shall not affect the validity or legality of the remainder of this Assignment.

4. Binding Effect. This Assignment shall be binding upon and inure to the benefit of and be enforceable by the successors and assigns of Assignor and Assignee.

5. Governing Law. This Assignment shall be governed by and construed in accordance with the internal laws of the State of Florida, without giving effect to any choice or conflict of law provision or rule (whether of the State of Florida or any other jurisdiction) that would cause the application of the Laws of any jurisdiction other than those of the State of Florida.

6. Counterparts. This Assignment may be executed in any number of counterparts and any party thereto may execute any such counterpart, each of which when executed and delivered shall be deemed to be an original and all of which counterparts taken together shall constitute but one and the same instrument. This Assignment shall become binding when one or more counterparts taken together shall have been executed and delivered by the parties. It shall not be necessary in making proof of this Assignment or any counterpart hereof to produce or account for any of the other counterparts.

7. Effective Date. This Assignment shall be effective as of June, 22, 2021, 2021 (the "Effective Date").


