TRADEMARK ASSIGNMENT

3. Assignor authorizes the United States Patent & Trademark Office, and any government official whose duty it is to record trademark registrations, applications and title thereto, to record the Mark as the property of Assignee, its successors, legal representatives and assigns in accordance with the terms of this instrument.

4. Assignor represents and warrants that it has the unrestricted right to convey all right, title and interest in the Mark, and that Assignor has not executed, and will not execute, any agreements that are inconsistent with this Assignment.

The undersigned, being duly authorized, have executed this Assignment as a sealed instrument as of the date first written above.


