**TERMINATION AND RELEASE OF
TRADEMARK SECURITY AGREEMENTS**

This Termination and Release of Trademark Security Agreements (this “Trademark Release”) is made as of June 30, 2021, by **CRYSTAL FINANCIAL LLC**, a Delaware limited liability company, as administrative agent and collateral agent (in such capacities, together with its successors and assigns, the “Agent”), for the Lenders and the other Secured Parties (as defined in the applicable Trademark Grants referred to below), **KPM ANALYTICS NORTH AMERICA CORPORATION (FORMERLY KNOWN AS PROCESS SENSORS CORPORATION)**, a Delaware corporation (“KANAC”), and **SENSORTECH SYSTEMS, INC.**, a Delaware corporation (“Sensortech” and together with KANAC, collectively, the “Grantors”).

WHEREAS, pursuant to (x) that certain Trademark Security Agreement, dated as of December 28, 2018 by and between KANAC and the Agent (as amended, amended and restated, restated, supplemented, modified or otherwise in effect prior to the date thereof, the “Original Trademark Security Agreement”), and (y) that certain Trademark Security Agreement, dated as of May 14, 2019, by and between Sensortech and the Agent (as amended, amended and restated, restated, supplemented, modified or otherwise in effect prior to the date hereof, the “Sensortech Trademark Security Agreement” and together with the Original Trademark Security Agreement, collectively, the “Trademark Grants”), the Grantors mortgaged, pledged, hypothecated, and granted to the Agent continuing Lien on and security interest (the “Security Interest”) in all of such Grantors’ right, title and interest in and to (i) the trademarks, trademark registrations and trademark registrations (collectively, the “Marks”) set forth on Schedule I attached hereto, (ii) all renewals and extensions of the foregoing, (iii) the goodwill of the businesses connected with the use of, and symbolized by, each of the Marks, and (iv) all income, royalties proceeds and Liabilities due or payable or asserted under and with respect to the foregoing ((i) through (iv) collectively, the “Trademark Collateral”);

WHEREAS, the Original Trademark Security Agreement was recorded with the United States Patent and Trademark Office (the “USPTO”) on December 28, 2018 at Reel 006565, Frame 0891;

WHEREAS, the Sensortech Trademark Security Agreement was recorded with the USPTO on May 15, 2019 at Reel 006645, Frame 0697; and

WHEREAS, the Grantors have requested that the Agent execute this Trademark Release in order to terminate and release the Agent’s Security Interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which is hereby acknowledged:

1. Defined Terms. Capitalized terms used herein without definition are used as defined in the Trademark Grants, as applicable.
2. Release of Lien. The Agent hereby terminates the Trademark Grants and hereby (i) terminates, cancels and releases the Security Interest and all other rights, liens and security interests that it has in, to and under the Trademark Collateral and (ii) reassigns, grants and conveys to each Grantor any and all right, title and interest it has in the Trademark Collateral, in each case, including, without limitation, those Marks referred to on Schedule I attached hereto and all renewals or extensions of all the foregoing.
3. Authorization to Record. The Agent authorizes and requests that this Trademark Release be filed with the USPTO and any applicable government officer record this Trademark Release.

4. Further Assurances. The Agent agrees to take all further actions and provide to Grantors, their successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of documents or other instruments), reasonably requested by Grantors to more fully and effectively effectuate the purposes of this Trademark Release, at Grantors' sole cost and expense, and without representation or warranty by the Agent.


5. Governing Law. This Trademark Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted with, the laws of the State of New York.

This Trademark Release may be executed in any number of separate counterparts, each of which shall, collectively and separately, constitute one agreement.
