WHEREAS Assignor acquired from Halliburton Energy Services, Inc., through a Trademark Assignment entered into as of March 30, 2020, all rights in and to the trademarks CAT MAGIC and FRESH & NATURAL, including the trademark applications and/or registrations listed in Schedule "A" (the "Trademarks");

WHEREAS Assignor assigned the Trademarks, for good and valuable considerations, to Assignee by transfer of assets on December 31, 2020;

2. Assignor hereby further confirms that the Assignment includes all rights to recover for past infringement of, or liabilities for, any of the rights relating to the Trademarks.
3. The Parties agree to take such further actions and execute and deliver such other documents, assignments, certificates, agreements and other instruments as may be necessary in order to implement the Assignment and transfer the ownership of the Trademarks unto the Assignee.
4. All costs and charges required for and/or related to the recordal of the present Confirmatory Trademark Assignment in the Territory, including, but not limited to, official and governmental fees, shall be borne by Assignee.

5. Assignor represents and warrants that at the time of execution of the Assignment, it was the owner of all rights, title, and interests in and to the Trademarks, that it had not assigned, transferred, licensed or encumbered its rights therein, and that it will not hereafter assign or attempt to assign any rights therein, or take any other action inconsistent with the Assignment.

6. This Confirmatory Trademark Assignment shall be governed by and construed in accordance with the applicable laws of the province of Québec and the laws of Canada applicable therein.
