RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL

WHEREAS, the Grantor has requested that the Lender release its security interest in all right, title and interest in, to and under the Intellectual Property Collateral.

NOW, THEREFORE, in consideration of the foregoing, the Lender hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, its security interest in all right, title and interest in, to and under the Intellectual Property Collateral, including the trademark registrations and applications set forth in Schedule I attached hereto and incorporated herein by reference, and agrees that all the security interest in the Intellectual Property Collateral is hereby discharged, terminated and released. The undersigned hereby transfers and assigns to the Grantor, without recourse, representation or warranty, any and all right, title and interest that the Lender may have obtained in, to and under the Intellectual Property Collateral under the Loan Agreement and the Agreement.
