**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN TRADEMARK COLLATERAL**

**THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL** (this "Termination and Release"), is entered into as of July 19, 2021 by **ALTER DOMUS (US) LLC**, as administrative agent for the Secured Parties (in such capacity, the "Agent") in connection with the grant of a security interest in certain trademarks by the Grantor party to the Trademark Security Agreement referred to below, in favor of the Agent. Capitalized terms used and not otherwise defined herein have the meanings assigned to them in the Subordinated Pledge and Security Agreement, dated as of October 6, 2020 (as the same may be amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"), among F45 Training Incorporated (the "Grantor"), certain of the Grantor's affiliates from time to time party thereto and the Agent.

WITNESSETH:

WHEREAS, the Grantor entered into that certain Notice of Grant of Security Interest in U.S. Trademarks with Alter Domus (US) LLC, as administrative agent under the Security Agreement, which was recorded in the Trademark Division of the United States Patent and Trademark Office on October 8, 2020 at Reel/Frame 7070/0039 (the "Trademark Security Agreement") for the purpose of providing certain trademarks and trademark applications as collateral security for the payment and performance of certain obligations of the Grantor to the Agent; and

WHEREAS, the Agent now desires to terminate and release its Lien on and security interest in the Trademark Collateral (as defined below);

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Definitions. The term "Trademark Collateral", as used herein, means the trademarks and trademark applications of the Grantor, including the trademarks listed on Schedule A hereto.

2. Release of Security Interest. The Agent hereby (i) terminates, cancels, releases and discharges its Lien on and security interest in the Trademark Collateral without representation, warranty or recourse of any kind or nature, and (ii) reassigns any right, title and interest it may have in, to and under the Trademark Collateral to the Grantor.

3. Further Assurances. The Agent shall, at the Grantor's sole cost and expense, and without representation, warranty or recourse, take all further actions, and provide to the Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments) reasonably requested by the Grantor to more fully and effectively effectuate the purposes of this Termination and Release.


4. Governing Law. THIS TERMINATION AND RELEASE, AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HEREUNDER SHALL BE GOVERNED BY, AND

CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK, WITHOUT REFERENCE TO CONFLICTS OF LAW PROVISIONS.
