## **RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT**

THIS RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT, effective as of May 14, 2018 (this "Release"), is made by and between Comerica Bank (the "**Bank**") and Telescope Inc. ("**Grantor**") under that certain Intellectual Property Security Agreement, dated June 29, 2017 (as amended, restated, supplemented or otherwise modified, the "**IP Security Agreement**"), by and between the Bank and Grantor.

WHEREAS, pursuant to the IP Security Agreement, which was recorded in the records of the United States Patent and Trademark Office on July 13, 2017, at Reel 6104 / Frames 0831-0836, Grantor granted to the Bank a continuing security interest in all of its right, title or interest in, to or under all Intellectual Property Collateral (as defined in the IP Security Agreement), including the registrations listed on the attached Schedule I; and

WHEREAS, pursuant to that certain Payoff Letter, dated as of May 14, 2018, executed and delivered by the Bank and acknowledged by Grantor, Grantor requested and the Bank agreed to (a) release any and all security interests it may have in the IP Collateral pursuant to the IP Security Agreement and (b) provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, termination, relinquishment and discharge of its security interest in the IP Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Bank does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the IP Security Agreement in the IP Collateral, (b) release and relinquish its security interest in, to or under all IP Collateral, and (c) discharge any and all rights, title and interest it has in and the security interest granted to the Administrative Agent in the IP Collateral. The Bank agrees, or authorizes Grantor, to make filings with the United States Patent and Trademark Office and take further actions, as reasonably requested by Grantor to evidence the release and termination of the Administrative Agent's security interests in the IP Collateral.

This Release shall be governed by, and construed and interpreted in accordance with, the laws of the State of California.
