## TRADEMARK ASSIGNMENT

### RECITALS

WHEREAS, Assignor, owns all right, title, and interest in and to the trademark and registration identified in **Exhibit A** attached hereto, and any related common law rights, and further including the goodwill associated with the trademark (collectively, the "Assigned Trademark"); and

WHEREAS, the Assignor is a wholly-owned subsidiary of the Assignee; and

WHEREAS, in connection with the Articles of Dissolution of WeShare, LLC, filed on July 20, 2021, the Assignor desires to distribute and assign to Assignee all of Assignor's rights throughout the world in and to, along with the right to recover damages and profits for past and future infringements of, the Assigned Trademark in accordance with the Plan of Complete Liquidation and Dissolution of WeShare, LLC.

### AGREEMENT

NOW, THEREFORE, for the good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, effective as of the Effective Date, Assignor hereby sells, assigns and transfers unto Assignee all right, title, and interest in and to the Assigned Trademark and any applications or registrations therefor, together with all common law rights therein, the goodwill of the business in connection with which the Assigned Trademark is used and which is symbolized by the Assigned Trademark, throughout the world, all renewals thereof, and all rights of action, powers, and benefits accrued thereto, including the right to sue for and collect damages and profits for past and future infringements thereof, to be held and enjoyed by the Assignee for its own use and benefit and for its successors and assigns as the same would have been held by Assignor had this Assignment not been made.

Where appropriate, the parties authorize and request the Commissioner of Trademark of the United States Patent and Trademark Office, whose duty it is to register trademark, to record Assignee as the assignee and owner of the Assigned Trademark.

This Assignment (i) may be executed in one or more counterparts and delivered by facsimile, portable document format or other electronic means, each of which when so executed and delivered shall be deemed to be an original and all of which together shall be deemed to be one and the same agreement; (ii) shall be binding upon and inure to the benefit of the parties hereto, and each of their successors and assigns; (iii) shall be governed in all respects by the internal laws of the State of Wisconsin, without regard to its conflicts of law principles which would require application of the laws of another jurisdiction; and (iv) may not be amended or modified unless in writing and signed by Assignee and Assignor.
