TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT is made as of the 2nd day of July, 2021, by and between PRINCIPIA VENTURES, LLC, a Pennsylvania limited liability company (“**Assignor**”) and HIGHWOOD USA, LLC, a Pennsylvania limited liability company (“**Assignee**”).

RECITALS:

B. Assignor has elected to transfer all of its right, title, and interest in and to the Trademark, and the business associated therewith, to Assignee.

AGREEMENT:

NOW, THEREFORE, in consideration of One Dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound hereby, Assignor hereby sells, assigns, and transfers unto Assignee the entire right, title, and interest in and to the Trademark, together with the goodwill of the business symbolized by the Trademark, and all claims for damages by reason of past infringement of the Trademark, with the right to sue for and collect the same for its own use and enjoyment, and for the use and enjoyment of its successors, assigns, and other legal representatives.

Assignor hereby warrants and represents to Assignee, its successors, legal representatives, and assigns, that, at the time of execution and delivery of this Agreement, Assignor is the sole and lawful owner of the entire unencumbered, right, title, and interest in and to the Trademark; that Assignor has the full right and lawful authority to sell and convey the same to Assignee as set forth herein; and that no party has been granted any rights in the Trademark by Assignor.

Assignor agrees that it shall execute and/or deliver any additional instrument, and shall take any additional steps, reasonably requested by Assignee in order to effect, evidence, or perfect Assignee’s rights in and to the Trademark.

This Trademark Assignment shall be executed simultaneously or in counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same agreement. The parties agree that facsimile signatures on this Agreement shall be deemed effective and equivalent to original signatures.

This Trademark Assignment is made and shall be governed by and construed in accordance with the laws of the Commonwealth of Pennsylvania, exclusive of any conflicts of law principle that would apply the law of another jurisdiction.
