TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT (this “Release”) is made as of July 30, 2021, by NXT Capital, LLC, in its capacity as administrative agent for the Secured Parties (“Agent”) in favor of Louisiana Fish Fry Products, Ltd., a Delaware corporation (the “Grantor”). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Collateral Agreement (as defined below).

WITNESSETH:

WHEREAS, pursuant to the terms of that certain Guarantee and Collateral Agreement, dated as of October 5, 2018 (as the same may be amended, restated, supplemented or otherwise modified from time to time, the “Collateral Agreement”), among Agent, the Grantor and one or more of its affiliates, the Grantor was required to execute and deliver to Agent, for the benefit of the Secured Parties, the Trademark Security Agreement (as defined below);

WHEREAS, Agent and the Grantor were parties to that certain Trademark Security Agreement, dated as of October 5, 2018 (the “Trademark Security Agreement”), pursuant to which the Grantor granted, collaterally assigned and pledged to Agent, for the benefit of the Secured Parties, a continuing security interest in all of the Grantor’s right, title and interest in, to and under Trademark Collateral (as defined below), including the Trademarks set forth on Schedule 1 hereto; and

WHEREAS, the Trademark Security Agreement was recorded by the United States Patent and Trademark Office (“USPTO”) on October 8, 2018, at Reel 6500, Frame 0584; and

WHEREAS, Agent has agreed to release its security interest in and lien on all of the Grantor’s right, title and interest in, to and under the Trademark Collateral and reassign the same to the Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby releases, terminates and discharges its continuing security interest in the Grantor’s entire right, title and interest in and to the following, whether now owned or existing or hereafter created, acquired or arising (collectively, the “Trademark Collateral”):

(i) each Trademark listed on Schedule 1 annexed hereto, together with any reissues, continuations or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark; and


(ii) all products and proceeds of the forgoing, including without limitation, any claim by Grantor against third parties for past, present or future (a) infringement or dilution of any Trademark, or (b) injury to the goodwill associated with any Trademark.

2. Agent hereby reassigns, grants and conveys to the Grantor, without any representation, recourse or undertaking by Agent, all of Agent's right, title and interest (if any) in and to the Trademark Collateral.
