RELEASE OF SECURITY INTERESTS IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (the “**Release**”), is executed by **AVIDBANK**, a California banking corporation (the “**Bank**”), for the benefit of **SUNERA LLC**, a Florida limited liability company (“**Grantor**”). Capitalized terms used in this Release and not otherwise defined herein have the meanings specified in the Security Agreement and IPSA (as defined below).

WHEREAS, the Grantor and the Bank entered into that certain Loan and Security Agreement dated as of July 9, 2019 (as the same may be amended, supplemented, or otherwise modified from time to time, the “**Security Agreement**”) and Intellectual Property Security Agreement (the “**IPSA**”); and

WHEREAS, pursuant to the Security Agreement, IPSA and connection with certain other loan documents, the Grantor granted the Bank, security interests in and to certain Intellectual Property Collateral of the Grantor, including those trademarks listed in Schedule A, attached hereto, for the purpose of securing certain obligations of the Grantor to the Bank thereunder (collectively hereinafter, the “**Intellectual Property**”); and

WHEREAS, the Bank recorded the IPSA with the United States Patent and Trademark Office on July 10, 2019, at Reel/Frame No. 6690/0325; and

WHEREAS, all of the indebtedness and other obligations secured by the Bank’s security interest in the Intellectual Property have been repaid in their entirety by the Grantor, and the Bank is therefore obligated to release its security interest in the Intellectual Property of the Grantor.

NOW, THEREFORE, for and in consideration of the premises and mutual promises in the Security Agreement, IPSA and herein contained, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantor and the Bank agree as follows:

The Bank hereby terminates the IPSA, and terminates and releases its security interests in the Intellectual Property, and the Bank hereby assigns and transfers to the Grantor, without any representation, warranty, or recourse whatsoever, the Bank’s entire right, title, and interest in and to the Intellectual Property, effective as of the date set forth above.


The Bank hereby agrees to execute such further instruments and documents and perform such further acts as the Grantor may deem reasonably necessary to secure to the Grantor the rights herein conveyed.
