ARTICLES OF AMENDMENT TO THE ARTICLES OF ORGANIZATION  
OF  
TRANSPORTATION IMPACT, LLC

Pursuant to Section 57D-2-22 of the General Statutes of North Carolina, the undersigned limited liability company hereby submits these Articles of Amendment for the purpose of amending its Articles of Organization:

2. The text of the amendment to the Articles of Organization is as follows:

The Articles of Organization of the limited liability company hereby are amended by deleting Paragraph 1 thereof in its entirety and inserting in lieu thereof the following new Paragraph 1:
