**DECLARATION CONCERNING OWNERSHIP OFFERED
PURSUANT TO TRADEMARK RULE 3.73 AND
TRADEMARK MANUAL OF EXAMINING PROCEDURE §502.01**

TO THE COMMISSIONER OF PATENTS AND TRADEMARKS:

1. My name is Eda Karesin , and I am the current Senior Principal, Corporate Development, of Airbnb, Inc. This Declaration is submitted as evidence of a chain of title from Tilt.com, Inc., the original owner of the above-referenced federal trademark registration, to Airbnb, Inc., its current owner.

2. In or about February 21, 2017, Airbnb, Inc. purchased the assets, including the intellectual property of Tilt.com, Inc., in accordance with the terms and conditions of a Purchase, Release, and Waiver Agreement including, without limitation, the assigned trademarks identified on Schedule 3(a) to the Purchase, Release, and Waiver Agreement, which incorporates explicitly the intellectual property on Section 5.5(e) of the Disclosure Schedule. Included on Section 5.5(e) of the Disclosure Schedule was U.S. application Serial No. 86/729,276. Schedule 3(a) of the Purchase,

Release, and Waiver Agreement and Section 5.5(e) of the Disclosure Schedule are attached as collectively as **Exhibit 1**.

3. Tilt.com, Inc. was subsequently administratively dissolved by the Delaware Secretary of State on October 19, 2017.

4. On July 2, 2019, application Serial No. 86/729,276 for the TILT mark (the “TILT Mark”) covering “providing online event registration services for attendance at social events and mixers, and live entertainment and performance events, and cultural activities” in Class 35, “providing electronic communications over a computer network and transmission of information by electronic communications networks in the nature of financial services, namely, the communication of payment card and disbursement transactions over an electronic communications network” in Class 38, and “providing a website featuring information about entertainment ticketing reservations” in Class 41 matured to registration (U.S. Reg. No. 5,791,164). Tilt.com, Inc. used the TILT Mark in connection with a crowdfunding company that allowed for groups and communities to collect, fundraise, or pool money online.

5. Since the Purchase, Release, and Waiver Agreement transaction in February 2017, Airbnb, Inc. has been the sole and exclusive owner of the TILT Mark and should be shown as the registrant of U.S. Reg. No. 5,791,164.

6. I reviewed the purchase agreements related to each such transaction. This declaration is based on my personal knowledge and on documents maintained Airbnb, Inc. in the ordinary course of business.

I, **Eda Karesin** of **Airbnb, Inc.** being hereby warned that willful false statements and the like so made are punishable by fine or imprisonment, or both, under Section 1001 of Title 18 of the United States Code and that such willful false statements may jeopardize the validity of the registrations referred to herein, declare that the foregoing is true and correct.
