Confirmatory Grant of Trademark Security Interest

This Confirmatory Grant of Trademark Security Interest (the "Confirmatory Grant") is made effective as of March 16, 2021 by and from BPP HOLDINGS LIMITED a private limited company organized under the laws of the United Kingdom (the "Grantor"), having its chief office at BPP House, Aldine Place 142/144 Uxbridge Road London, UNITED KINGDOM W12 8AW, to and in favor of GLAS Trust Corporation Limited (the "Security Agent") as agent and trustee for the Secured Parties under and as defined in the Debenture and Deed of Accession, (as amended, restated, supplemented or otherwise modified, the "Agreement") by and between Grantor, BPPH1 Limited, and Security Agent.

This Agreement is executed pursuant to the terms of the Agreement dated as of March 16, 2021 for the ratable benefit of the Secured Parties.

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, the Grantor hereby grants to the Security Agent, for the ratable benefit of the Secured Parties, a security interest in all of the Grantor's right, title and interest in, to and under the following, whether presently existing or hereafter arising or acquired:


- (i) each Trademark, all of the goodwill of the business connected with the use of, and symbolized by, each Trademark, including, without limitation, each Trademark, described on Schedule A;
- (ii) all products and proceeds of the foregoing; and
- (iii) any and all claims and causes of action, with respect to any of the foregoing, whether occurring before, on, or after the date hereof, including all rights to and claims for damages, restitution, and injunctive and other legal and equitable relief for past, present, and future infringement, dilution, misappropriation, violation, misuse, breach, or default, with the right, but no obligation, to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.

The rights and remedies of the Security Agent, on behalf of the Secured Parties, with respect to the security interest granted herein are without prejudice to, and are in addition to, those set forth in the Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Confirmatory Grant are deemed to conflict with the Agreement, the provisions of the Agreement shall govern.
