**RELEASE OF TRADEMARK SECURITY AGREEMENT**

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT, dated as of August 2, 2021, (this “Release”) is made by JPMORGAN CHASE BANK, N.A. (“Assignee”) in favor of FRANCIS COPPOLA WINERY, LLC, a Delaware limited liability company (the “Assignor”). Capitalized terms used but not defined herein have the meanings provided in the Security Agreements (defined below).


WHEREAS, pursuant to the Trademark Security Agreement dated June 15, 2015 and recorded at the United States Patent and Trademark Office on June 15, 2015 at Reel 5556 and Frame 0001, the Trademark Security Agreement dated May 14, 2019 and recorded at the United States Patent and Trademark Office on May 14, 2019 at Reel 6645 and Frame 0297, and the Trademark Security Agreement dated September 23, 2020 and recorded at the United States Patent and Trademark Office on September 24, 2020 at Reel 7060 and Frame 0292 (collectively, the “Trademark Security Agreements”), and the Pledge and Security Agreement, dated as of June 15, 2015 (as amended or modified from time to time, including pursuant to that certain Supplement to Pledge and Security Agreement, dated as of May 14, 2019, the “Security Agreement”; together with the Trademark Security Agreements, the “Security Agreements”), the Assignor granted to the Assignee, for the benefit of the Secured Parties, a continuing security interest in, to and under the Collateral (as defined in the Trademark Security Agreements), including the Trademarks set forth on the attached Schedule I, together with the goodwill of the business symbolized by Assignor’s Trademarks (collectively, the “Trademark Collateral”).

WHEREAS, Assignor has requested and the Assignee has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Trademark Collateral (the “Released Collateral”).

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Assignee, on behalf of the Secured Parties, does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the Security Agreements in the Released Collateral, (b) release its security interest in the Released Collateral, (c) discharge any and all rights, title and interest it has in and the security interest granted to the Assignee in the Released Collateral, and (d) reassigns, grants and conveys to Assignor any and all right, title and interest it has in the Released Collateral.
